NEW BUSINESS: Are we interested in renting the pavilions and the park and for how much? This would be up to the Park Committee. The Park Committee voted yes for \$50.00, Clerk to come up with a rental agreement. On the same note, can Operation Lend a Hand hold a car show in the park. The Park Committee voted yes with no cost as this is a non-for-profit organization.

OLD BUSINESS: Ordinance 2025-01 was presented for second reading and third meeting and approved. Ecker accepted -aye, Young seconded - aye, Welch, aye The Sewer Shut off system can be utilized, and the Health Department will be contacted, and an order will be placed for the household to be unhabitable.

PD: Yards have been evaluated and letters out to residents.

MVH: It was brought to their attention that some of the equipment at the park was unsafe, however, they have looked at all the equipment and do not find anything to be worried some. The street Dept received a thank you from a park neighbor that helped her out while they were mowing the park. The tile at the park that was broken is nowhere in the records that it exists and will be capped off and filled in.

SEWER: Creed Septic Service has increased their prices; however, they have not had a price increase since 2016 and will most likely be the cheapest, however, SBOA may need us to bid out the service to confirm that is the case. They have increased by \$40.00 for residential. Panel still being built, had an 8-10 week wait. Parts are almost ready. The \$20,000 quoted to fix the clarifier has also now increased to \$21,600 and the price will continue to rise unless we fix within the remainder of the year. Ecker made a motion to go ahead and get fixed sooner rather than later, Young, seconded, Ecker – aye, Young – aye, Welch – aye

PATRON:

ATTORNEY: There will be a proposal coming out for standards in Marshall County for landlords that if the landlord is abiding be the rules and the tenants come in and junk the area to hold tenants responsible. This would be a health code that towns can adopt.

CLERK: discussed a call in regards to 212 South St which is the house that had a fire in Feb. Owner wants to disconnect sewer and trash. Sewer can be capped off and inspected and the sewer department can let the clerk know when it is ok to discontinue sewer services. However, trash is not able to be disconnected as the town as a whole is serviced and contracted based on how many residents there are, not by how many use the service. There is no discount for snowbirds and this would be treated the same way.
